Some years ago when fur sales dropped in many European countries, Italy climbed to number 3 on the world's list of fur buyers. 25% of all Italian women owned a fur coat. Animal welfare societies in Italy got ready to take action. At that exact moment WSPA NO FUR campaign was introduced into Italy. In the spring of 1989 WSPA campaign experts travelled to Italy. As a result, Victor, WSPA's Baby Red Fox is now dis-

tributed widely in Italy.

In November 1989 the women's magazine "Donna", produced a special issue on fur. Heavily sponsored by the fur industry, it claimed that NO FUR campaigns had no impact at all. Recently the Associazione Italiana Pellicceria (AIP), the Italian furriers, placed a one page ad. The headline was: "Is Killing An Animal A Crime?" It placed fur in the same line as crocodile skin, snake skin and pate foie gras in an attempt to justify fur. Latest news is that Italian furriers threatened an Italian clothing company that speaks out against furs with a damage claim of US\$ 750,000. The furriers claim in a 12-page letter that their total loss is now 40 million Dollars as a result of No Fur campaign.

Subsidized Seal Hunt

Thanks to a 1.7 million Canadian Dollar loan, the Northeast Coast Sealers Co-operative will again this year be able to hunt off the coast of Newfoundland. The Newfoundland Development Cooperation provided the money to kill 50,000 seals. The Green Party in Newfoundland is favorable to the seal hunt. In 1989 a total of 8,694 licenses to hunt seals were issued by the Canadian authorities. As a result 66,175 seals were killed. 226 Hooded seals, 64,089 harp seals, 1,860 other species. On the 12th of April 1990, the score of the kill was 5,332 harp seals, 33 hooded seals and 753 of other species of seal.

Section 4 of the Motor Vehicles Administration Act prohibits:

"Ethnic slurs, Religious slurs, Foul language, Sexual connotations, Political slurs, Controversial message....." BAN FUR seems to be in one of these categories. The solicitor General of the Alberta Motor Vehicles Division determined that this plate had unfortunately been missed in the edit and screening

process.
